On August 29, 2006, the Board of Directors of **RSAS** enlarged the existing financial policy that established a "love offering" format for professional services rendered. The new policy reads:

"Be it resolved that the Board of Directors of Rock Solid Administrative Services state that it is the clear purpose of RSAS to provide administrative support, consulting, education, professional outsourcing, and products to the community without formal fee or bias of any nature."...

"It is further resolved that the Board of Directors do support the provision of charitable contributions in the form of love offerings for the various aforementioned services that may be provided by those being served but that no pre-established amount for those services will be advertised or required. The Board of Directors supports the receiving of a love offering so that the charitable purposes of RSAS can be facilitated and perpetuated. In order to support the ongoing work of this corporation, public solicitation for donated funds shall be continued to make up any difference that may occur between operational need and love offerings provided."



### WHY?

The reason for this resolution is to address the incredible need for administrative assistance in the nonprofit community —especially in smaller churches & organizations. In a day where legal and procedural input is vital to survival, many of those being served would lack the administrative



infrastructure to support their operations. Without our help, many charitable purposes and ultimate community impact could be lost. **RSAS** statistics show that since January 2005 the number of organizations participating with **RSAS** has increased--mostly because of our love-offering format. However, the revenue for the assistance we provide has significantly decreased. Smaller organizations just do not have the finances to support administrative needs.
